Junior Exhibitor Rules

- Must be 21 years of age or younger as of March 19th, 2022
- Include birthday for each junior exhibitor
- Only juniors may fit animals for the Junior Show. If adult participation takes place on a steer or heifer, **that animal will not be allowed to show in the Junior Show**
- Animals entered in the Junior Show, must be entered in the junior exhibitor's name
- The **Junior Exhibitor must show his/her own animal in their respective class**, with the exception of the championship class, where if a junior exhibitor has more than one animal qualified, they may get another junior exhibitor to show one of their animals for them. The animal must be shown by the person who the animal is entered under.
- No showman substitutions. **NO JOINT ENTRIES ALLOWED.**

***All Junior Show animals must be entered in the Open GMACK Steer or Heifer Show.**

***Any animals entered in the open show must include the junior exhibitor's name if that animal is shown in both shows.**

- All animals must be halter broke
- All steers and heifers must be born in 2021
- All steers will be allocated into classes by weight, and shown lightest to heaviest
- Heifers will be split into classes by birth date, shown youngest to oldest
- The number of classes will be determined after entries close
- Top two from each class will compete for the Grand and Reserve Champion

GENERAL RULES & INFORMATION

1. The show will be held under the management of the Lloydminster Agricultural Exhibition Association Ltd.
2. There will be absolutely no tolerance for verbal or physical abuse towards any of the LAEA staff and/or volunteers.
3. The show is open to all, but the Committee reserves the right to refuse any entry.
4. The Committee in Charge reserves the right to decide any point not covered by the rules and to correct any error or make any necessary alterations in the Rules and Prize List.
5. All animals being exhibited must be halter-broken and must be securely tied or in the charge of a competent person. No animals shall be allowed to remain loose on the grounds. **NO ANIMAL SHALL BE ALLOWED ON THE GROUNDS THAT IS NOT ENTERED FOR THE SHOW.**
6. There will be no public tie-outs available, but exhibitors can tie animals in stock trailers overnight if they wish. These stock trailers **MUST** remained on LAEA grounds. Animals **MUST** be onsite by 8:00 am on Saturday and **WILL NOT** be released until 2:00 pm on Sunday.
7. All animals on the grounds will be subject to veterinary inspection if necessary. No animal having a contagious disease shall be allowed to occupy any stall or building on, or be admitted to, the Exhibition grounds, and if any animal has been admitted through an oversight, suffering from any such disease, the Manager shall immediately order its removal from the grounds.
8. Tampering with animals to hide physical defects is prohibited. This includes surgical alterations, tranquilizers or any other practice that might misrepresent the animal's true characteristics. Any products/solutions/liquids administered internally to alter the conformation or weight of the animal is prohibited. Offenders will be subject to penalties imposed at the discretion of the Committee.
9. No person will be allowed to act as judge who is in any way interested in the exhibits that person is to judge.
10. The Exhibitors and grooms are to appear in the ring neat, clean and suitably attired.
11. No animal shall have on or about it any prize colours or cards until the awards have been made in their respective classes.
12. No animal shall be considered by the Judges in awarding prizes unless the Exhibitor's number is conspicuously displayed.
13. Animals winning prizes must not leave the ring until the prize has been awarded to them.

Consumption of Alcohol

There is an ongoing issue that has been brought to our attention. The issue is consumption of alcohol by minors in the barn area and at our socials. This issue has become increasingly obvious over the past few years. Even though we I.D. the younger people, there seems to be a number of false I.D's showing up and or some of the people of age are obtaining the alcohol for the minors.

All of our facilities are licensed under the Association's name. If minors are consuming alcohol in the barn area or at our socials, this infraction could have a significant effect on our Association's liquor license.

The solution that the committee has implemented is that any person appearing to be 25 and under must provide proper government picture I. D. to purchase or obtain alcohol. If we see minors consuming alcohol, or displaying the effects of consumption of alcohol, we have been directed by the Committee to contact the RCMP. In addition, the RCMP have indicated that they want to be more visible at our events. Be advised that you may see RCMP members walking through the facilities/barns at any given time, at their discretion.

The Association did not make the laws for legal drinking age, and we are obligated to protect ourselves the best we can in this situation.

We trust that the exhibitors and parents will take this very seriously, as we will have little choice but to act to enforce the situation.

Notwithstanding anything to the contrary herein contained, it is understood that each entrant by the act of entry or exhibiting waives all claims against the Lloydminster Agricultural Exhibition Association Ltd., and/or any of the members, officers or agents thereof for any injury, loss or damage which he, his employees, helpers and/or property may sustain in any way arising out of the operations or activities of the said Company, by any of his helpers or employees or their executors, administrators or assigns, and that any helpers or assistant introduced to or engaged by the entrant through the said Company or through its members, officers or agent shall be at the sole risk and responsibility of such entrant.

The Directors and Committee Members, will be taking every precaution, cannot hold themselves responsible for any damage to or loss of exhibits.
