EXCLUSION OF LIABILITY ASSUMPTION OF RISK, JURISDICTION

As a condition of participation in the **Lloydminster Parade of Lights**, I, the Participant, assume all risk of personal injury, death, or property loss resulting from any cause whatsoever including but not limited to the negligence, breach of contract, or breach of statutory duty of care on the part of the Lloydminster Agricultural Exhibition Association Ltd., their Directors, Officers, Volunteers, Employees, Agents, Representatives or Sponsors, the City of Lloydminster and their Directors, Officers, Volunteers, Employees, Agents, Representatives or Sponsors (hereinafter collectively referred to as the "Parade Operators"), and Ryan LeBlanc or any **Parade Of Lights** Committee member. The Participant agrees that the Parade Operators shall not be liable for any such personal injury, death or property loss and releases the Parade Operators and waives all claims with respect thereto. The Participant agrees that any litigation involving the Parade Operators shall be brought solely within the Province of Alberta and shall be within the exclusive jurisdiction of the Courts of the Province of Alberta. The Participant further agrees that these conditions and any rights, duties, obligations as between the Parade Operators and the Participant shall be governed by and interpreted solely in accordance with the laws of the Province of Alberta and no other jurisdiction.

Parade of Lights Participant's Information

1. **ALL PARADE ENTRIES SHOULD ARRIVE AT THE LLOYDMINSTER EXHIBITION GROUNDS NO LATER THAN 5:45 pm ON DECEMBER 22nd, 2022**
 - a. **IF ARRIVING LATER, YOU WILL NOT BE JUDGED FOR YOUR CATEGORY**
 - b. **Anyone who has a float in the parade must tell their riders/participants what section they are in and where to find their float.**
2. All Parade participants should follow the **PARADE MARSHAL'S** direction for their designated spot and move slowly and safely along the parade route. Parade exits at 56th Street on 49th Avenue.
3. No obscuring vehicle safety equipment.
4. Units are to move at assigned speed along route.
5. **ALL PARADE ENTRIES MUST BE DECORATED.**
6. **For safety purposes** no vehicle shall cover Headlights/Signal lights/Tail lights with extra lighting.
7. All signal and safety lights must be highly visible and stand on their own.
8. **ENTRIES ARE ENCOURAGED TO INCORPORATE MUSIC.**
9. **ABSOLUTELY NO CANDY OR ARTICLES ARE TO BE THROWN FROM THE FLOAT TO THE SPECTATORS.**
10. NO WATER BALLOONS OR WATER GUNS, etc. are allowed.
11. A copy of your General Liability and Property Damage Insurance Policy must be shown upon request.
 - a. Requires that all participants in the Parade of Lights carry liability insurance. This requirement protects the participant against any liability claims arising out of participation in the parade. An example of a potential claim could be a spectator who was injured by being hit or run over by a moving float. Liability insurance would provide the participant protection against this type or some other unforeseen accident. A request to your insurer may be made for an extension to your business liability or personal (home, tenant, farm) liability policy to cover your participation in the parade. If you are uncertain of your coverage, you should contact your insurance agent or broker to ensure you have the required liability protection.
 - b. You are required to provide a certificate of insurance with Lloydminster Exhibition Association and the City of Lloydminster listed as additional insured for a minimum of \$2,000,000.00 liability; Re - Insurance Coverage Requirement-Parade of Lights.
