- Each participant is responsible to bring their own equipment: trimming chute, halters, show sticks, clippers, grooming and showing supplies

This clinic is designed to instruct 4-H members in the technique of judging beef (heifers and bulls), sheep/goats, horses, and two mystery classes – 4 animals/subjects per section will be judged, 35 minutes per section allowed. There will be two oral reason classes for each age category at this clinic.

This competition is open to all 4-H members. Any 4-H member, from any province, in any project is welcome to attend and take part in the clinic. Participants will be divided into Cloverbud, Junior, Intermediate (if numbers warrant) & Senior divisions according to the provincial regulations.

There will be prizes awarded for the top 3 in each age category. Prizes will also be awarded to the top 8 Saskatchewan 4-H Senior members who will be going on to the provincial competition.

#### ARBY'S PROVINCIAL 4-H JUDGING COMPETITION

- 1. This competition is open to any registered Saskatchewan 4-H member who is 15 21 as of December 31st of the membership year. Due to International Judging rules at Canadian Western Agribition, only 4-H members 17 21 years of age can qualify to compete in the Canadian National 4-H & Youth Judging Competition at Agribition. Regional competitions encourage members 15 & 16 years of age to participate in the competition to increase experience in knowledge of competitive judging. This is one of the 5 regional competitions where senior 4-H members can qualify to enter the Saskatchewan Provincial 4-H Judging Team Selections. The 4-H members placing in the top 8 in this competition will be invited to take part in the Saskatchewan Provincial Team Selections which will be held in Swift Current (dates TBD). Other regional competitions will be held in Saskatoon, Weyburn, Swift Current, and Whitewood. A 4-H member may choose to participate in any or all of the regional qualifying competitions but may only qualify once. Members who have qualified, including four alternates, may enter and participate but cannot qualify again in any subsequent competition.
- 2. Contestants shall come under the supervision and direction of the 4-H Judging Committee and shall observe all rules and regulations printed in the prize list as they apply here.
- 3. All entries must be on the printed forms supplied for the purpose. The particulars called for on the entry form must be fully and correctly supplied and written in clear, legible writing or type written and properly signed.
- 4. **CERTIFICATION OF ENTRIES**: Parents or guardians must certify on the entry form that the exhibitor is within the age limits specified in the competition and must belong to a 4-H Club. No entry form will be accepted unless it conforms to these requirements.
- 5. Competition will consist of the live judging of heifers, bulls, sheep, draft horses, two mystery classes and a WRITTEN EXAM.
- 6. For the benefit of the contestants, there will be demonstrations of judging techniques on each of the six categories. Contestants will be asked to judge the classes providing written reasons for all categories and giving oral reasons for two classes. Oral reasons are assigned at random and will be posted prior to competition.
- 7. A total of twenty (20) minutes per class will be allotted for the "in the ring" judging.
- 8. Aggregate scores will be based on total scores of the six categories plus scores of two classes of oral reasons.
- 9. The official judge will break ties. In the event of a tie in the aggregate, the higher standing will be given to the higher total score in oral reasons.
- 10. The official judge's decision is final.
- 11. Contestants must enter all the judging classes and must hand in six completed judging cards, written exam and complete two oral reasons to be eligible for an award.
- 12. Entry fee: \$35.00 per clinic, plus GST (includes lunch). There will be no refunds.
- **13.** Any participants caught working together will be disqualified.





### **GENERAL RULES**

- 1. The show will be held under the management of the Lloydminster Agricultural Exhibition Association Ltd.
- 2. The show is open to all, but the Committee reserves the right to refuse any entry.
- 3. The Committee in Charge reserves the right to decide any point not covered by the rules and to correct any error or make any necessary alterations in the Rules and Prize List.
- 4. Order of events subject to change by the Program Committee. Participants are requested to watch progress of the judging called into the ring. Participants must be in the show ring promptly after being called. Participants failing to comply with this rule will be excluded.
- 5. No person will be allowed to act as Judge who is in any way interested in the exhibits that person is to judge. No person other than officials, stewards and attendants on duty, and the Judge of the class may enter the show ring without the permission of the management.
- 6. The Exhibitors and grooms are to appear in the ring, neat, clean, and suitably attired.
- 7. No exhibitor shall have on or about it any prize colours or cards until the awards have been made in their respective classes.
- 8. Exhibitors winning prizes must not leave the ring until the prize has been awarded to them.
- 9. Notwithstanding anything to the contrary herein contained, it is understood that each entrant by the act of entry of exhibiting waives all claims against the Lloydminster Agricultural Exhibition Association Ltd. and/or any of the members, officers or agents thereof for any injury loss or damage which he, his employees, helpers and/or property may sustain in any way arising out of the operations or activities of the said Company, by any of his helpers or employees or their executors, administrators or assigns, and that any helpers or assistant introduced to or engaged by the entrant through the said Company or through its members, officers or agent shall be at the sole risk and responsibility of such entrant.

Exhibitors of animals are liable to occasional accidents, injury or damage to persons coming into contact with them, and therefore shall guard their exhibitors and protect the public from coming in contact herewith, and every such exhibitor shall indemnify the Lloydminster Agricultural Exhibition Association Ltd. from and against all claims and demands, costs, charges and expenses which it may incur, suffer or be put to, by reason or an accident or of any such exhibit not being properly guarded or the public not being protected therefrom. The Directors and Committee members, while take every precaution, cannot hold themselves responsible for any damage to or loss of exhibits.

Should any question or dispute arise, not provided for in the rules, it shall be referred to the Committee in Charge.
