****NO STRAW IN BARNs****

- There will be no paper check of animals. The Cattleman's Call committee is relying on the due diligence of the exhibitors to have their animals registered for this show.

All bulls over 12 months of age entered in the show must have a **NOSE RING (NO HUMBUGS)**.

SPLIT CLASSES: Classes will be split at the discretion of the committee. The prize money will be equally split. The committee will split the class after the cattle are on premises. First and second placing from each split will compete for championship of the division.

- Cattle are shown within classes youngest to oldest.
- Percentage bulls and heifers permitted to show in Halter & Pen Shows
- All percentage animals must be registered with their respective breed associations
- No cross entries between Halter & Pen Shows permitted
- No restriction on multiple exhibits in any classes, excluding Breeder's herd.

GENERAL RULES AND REGULATIONS

Exhibitors are requested to familiarize themselves with the following Rules and Regulations governing Lloyd Ex Cattleman's Call, as they will be strictly enforced.

1. **VIOLATION OF RULES** – All entries for exhibits, shows, sales and displays in the annual show sponsored by Lloydminster Agricultural Exhibition Association Ltd. are subject to the Rules and Regulations and any violation will subject exhibitors to such penalties the Management Committee may stipulate.
2. **INTERPRETATION** – The Board of Directors has the final and absolute right to interpret these Rules and Regulations and determine all matters, questions, or differences in regard thereto, or otherwise arising out of or in connection with or incident to Lloyd Ex Cattleman's Call. The Board of Directors has the right to amend or to add to these Rules and Regulations.
3. **LIABILITY** – The Board and Committee members, while taking every precaution, cannot hold themselves responsible for any damage to or loss of any exhibit.
4. Every exhibitor shall be deemed to be in full charge of and responsible for their exhibit and the Association shall not be liable for any loss to any such exhibits, or for injury or damage thereto from the time that such exhibit commence to be transported to the premises of the Association until such exhibit is delivered there on and every exhibit on such premises shall be deemed to be at the risk of the exhibitor, except in the case of any exhibit being sold, when the same shall remain on such premises at risk of the purchaser at such sale, and in either case the Association shall not be liable for the loss of any such exhibit or for any injury or damage thereto, notwithstanding such loss, injury or damage arising through or by negligence of the Association of any of its officers, servants or agents.
5. If any damage, loss or injury to person or property shall be caused by neglect or willful act of any person, firm or any corporation, or their agents, representative, servants, or employees having license or privilege to exhibit on said Exhibition property, occupying any space thereof, the Lloydminster Agricultural Exhibition Association Ltd. shall in no manner be responsible; therefore, shall indemnify the said Lloydminster Agricultural Exhibition Association Ltd.
6. **ENTRIES**
 - a) Overall Grand Champion and Reserve Champion on Halter will receive a belt buckle as a prize.
 - b) Grand Champions in all other classes, both halter and pen shows, will receive a belt buckle as a prize. Reserve Champions in all other classes, both halter and pen shows, will receive a vest as a prize. Grand Champions and Reserve Champions of Pair of Bulls and Breeder's Herd will receive a crafted crib board as a prize.
 - c) The number of exhibitors permitted in each classification will be as follows: NO RESTRICTION ON MULTIPLE EXHIBITS IN ANY CLASS, excluding Breeder's herd.
 - d) Unless otherwise indicated, all classes in livestock exhibits will be open to all competitors.
 - e) Vest sizing available at the Lloyd Ex office. Buckles for Divisions will be mailed to winners after the show to ensure correct sizing and numbers. The Grand and Reserve halter buckles will be onsite.
7. Split Classes: Classes will be split at the discretion of the committee and prize money (if applicable) will be equally split. The Committee will split the class after the after the cattle are on premises. First and second placing from each split will compete for the Championships of the division.

GENERAL RULES AND REGULATIONS (continued)

8. **ONLINE ENTRIES** – All entries are to be made ONLINE through AssistExpo at www.lloydex.com/cattlemans-call and must be accompanied by fees, made payable to:
- LLOYDMINSTER AGRICULTURAL EXHIBITION ASSOCIATION LTD.
9. **ENTRY FEES** – will be charged out at \$40.00 per animal, plus \$10.50 environmental fee. Therefore, a pen of 2 will have an entry fee of \$80 and an environmental fee of \$21.00 and a pen of 3 will have an entry fee of \$120.00 and an environmental fee of \$31.50. Halter animals will also be charged a Straw Fee for Tie Outs of \$15.00 for the event.

10. **CLOSING OF ENTRIES** – will be at **5:00pm MST on Thursday, January 4, 2024**. All entries must be in the office by this time. **LATE ENTRIES WILL NOT BE ACCEPTED.**
11. **REFUSING ENTRIES**
- a) The Lloydminster Exhibition Association reserves the right to refuse any entry.
 - b) The Director or the President and General Manager, shall be at liberty, for cause, or in the uncontrolled discretion and reason therefore, to bar any exhibitor and/or any animal from participating in, or continuing to participate or compete in any event and may also cause any such animal to be removed from the premises by the Association.
12. **NO REFUNDS OF ENTRY FEES** – Exhibitors making entries and not exhibiting them shall forfeit all entry fees paid.
13. **SUBSTITUTIONS** – for all animals will be allowed until **5:00pm MST on Monday, January 8, 2024** at no charge. Purebred substitutions must be same type, and same calendar year. (e.g., January 2023 bull substituting for as March 2023 bull). All substitutions must be emailed to the Ag Manager @ agmanager@lloydex.com
14. **ERRONEOUS ENTRY** – Exhibits that have been erroneously entered may, at the discretion of the Committee Chairman, be transferred to the proper classes before judging. If such classes have been judged, they will not be re-judged.
15. All animals in the barns must be eligible and entered in a show; cattle not entered in a show cannot be in the barns nor on Exhibition property.

GENERAL RULES AND REGULATIONS (continued)

16. ARRIVAL AND RELEASE OF EXHIBITORS

- a) Move into barns starting at 9:00am MST on Thursday, January 11, 2024
- b) All livestock must be in the barn by 10:00am MST on Friday, January 12, 2024
- c) Release time after 4:00pm MST on Saturday, January 13, 2024
- d) Absolutely no stall signs or display materials to be taken down prior to 4:00pm MST
- e) If you require tie outs Saturday evening, please let the office staff or committee member know
- f) **Exhibitors violating the arrival & release time will be subject to a penalty as deemed necessary by the Lloydminster Agricultural Exhibition Association Ltd Cattleman's Call Show Committee**
- g) If you are an exhibitor at this show you are expected to keep your livestock on the grounds until the show is over

17. **TIE-OUT TIME** – will be after 7:00pm MST and animals must be in stalls before 8:00am MST

18. REGISTRATION OF ANIMALS FOR PUREBRED SHOWS

- a) All animals entered in the purebred and percentage shows must have a registration recognized by their respective breed association.
- b) Entries from Canadian herds must be registered in the recognized Canadian herd book in the name of the exhibitor on the closing date of entries. Entries from non-Canadian herds must be registered in the recognized herd book of their country in the name of the exhibitor as recognized by the Canadian Association on the closing date of entries. Name & number of sire and dam must be given in every case.
- c) There will be no paper check of animals. The Cattleman's Call committee is relying on the due diligence of the exhibitors to have their animals registered for this show.

19. **SHOW NUMBERS** – All entries in livestock classes will be printed in the show program, and exhibitors upon entering the ring, must use a number corresponding to the number in the show program, on the back of his/her show harness. The number will be supplied at no cost to the exhibitor.

20. **HEALTH REGULATIONS** – All current health regulations at the time of posting, import and export requirements change depending on disease control issues that arise in the country of origin or destination. Please contact your local accredited veterinarian for specific requirements.

21. **DISEASED ANIMALS** – All animals on the grounds will be subject to veterinary inspection if necessary. No animals having contagious diseases shall be allowed to occupy any stall or building or be admitted to Exhibition property and if any animal has been admitted through an oversight, suffering from any such disease, the Manager shall immediately order its removal from the grounds.

GENERAL RULES AND REGULATIONS (continued)

22. STALLING

- a) The Association will supply, free of charge, stable room and water for all animals properly entered
- b) Exhibitors must supply their own feed troughs and stall cards
- c) Participating exhibitors may post a sign at their stall of their own production sale
- d) All halter animal exhibitors are required to purchase the straw service from the Lloyd Ex Cattleman's Call Committee

23. **PLATFORMS** or other build up materials for use in stabling cattle will not be permitted.

24. All bulls over 12 months of age entered in the show **MUST HAVE A NOSE RING (NO HUMBUGS)**, before it will be allowed into the barns, and whenever the animal is moved out of its stall, a nose lead rope must be used.

25. BEDDING AND FEED

- a) Initial bedding of wood chips will be supplied by LAEA, the cost of which is included in the entry fee.

26. MANURE

- a) There will be areas designated for manure disposal

27. **CLIPPING AND CLIPPING CHUTES** – Clipping or grooming of cattle in the middle aisles of the barns is prohibited, except on the show day of each breed and then it is permitted under the supervision of the Barn Boss.

28. Pre-clipping of pen cattle is permitted. However, the pen show will be dry brush only (no aerosols). Full fitting (use of aerosols) is permitted for the halter show.

29. **FRAUDULENT PRACTICES** – Any exhibitor who makes a false entry or shall attempt to interfere with, or influence the Officials, while in the discharge of their duties or anyone using contemptuous or abusive language to an official in consequence of awards made, is liable to forfeit his right to all prizes he might otherwise be entitled to and may be excluded from exhibiting at this Exhibition. Officials are particularly requested to immediately report any infraction of this rule.

GENERAL RULES AND REGULATIONS (continued)

30. TAMPERING WITH LIVESTOCK

- a) Unethical fitting of cattle entered for competition is prohibited.
- b) For this show, unethical fitting will be deemed to consist of any treatment or operation materially altering the structure or the natural conformation of any part of the animal's body such as the introduction of air, liquids or other substances subcutaneously in any part of the body, surgical operation to exaggerate the natural conformation of the animal. Balancing the udder by artificial means.
- c) Any products/solutions/liquid administered internally to alter the conformation or weight of the animal is prohibited.
- d) Any animal which, in the opinion of an inspector or inspectors appointed for the purpose, has been unethically fitted shall forthwith be disqualified from exhibition and shall forfeit the right to be awarded any prizes or prize money and entry fees which may have been paid to the Association on account of its entry shall be forfeited. The opinion of the inspector or inspectors and any action which may be taken thereon may be reported to any Association for the registration of purebred livestock of which the exhibitor is a member.

31. DEFINITION OF ENTRY AND OWNERSHIP AS PERTAINING TO SINGLE & GROUP CLASSES

- a) All purebred registered animals, whether owned by one person or by more than one individually or jointly which are maintained on ONE FARM or BREEDING UNIT, are the production of THAT FARM OR BREEDING UNIT.
- b) BREEDING UNIT is defined as follows: Where the same or common interests are involved in more than one breeding operation, such operations are considered as ONE BREEDING UNIT.
- c) In all cases where there is any doubt that more than one breeding unit exists, the interpretation shall be that ONLY ONE BREEDING UNIT EXISTS. The responsibility of proof of separation of breeding units shall rest with the exhibitor(s).

32. **HERDSMAN AWARD** – Lloyd Ex Cattleman's Call Committee does not offer a Herdsman Award, but permission is given for any breed Association or club to offer a Herdsman Awards for their respective breed exhibitors.

33. **JUDGING** – No person will be allowed to act as Judge who is in any way interested in the animals that person is to judge.

34. **DECISION OF JUDGES** – A judge shall have uncontrolled power to decide all questions as to the winner of any event over which such judge presides and the awarding of the prize and the decision of such judge on any such question shall be final and there shall be no recourse therefrom. Where there is only one exhibitor in any event or where the judge is of the opinion that the animal exhibited does not justify an award, such judge may withhold the awarding of any award for the same or may award prizes according to the standard merited by reason of quality, rather than by reason of number of exhibits.

GENERAL RULES AND REGULATIONS (continued)

35. **TIME OF SHOWING** – The livestock show program will be published and exhibitors are required to act accordingly. Any animals not presented in the ring at the time scheduled will be barred from showing.
36. **SHOW RING RULES** – No person will be permitted in the show ring during the time of judging except the Judge(s) and ring person in charge of the animals, Lloyd Ex Cattleman's Call committee members and official photographer.
37. **ALCOHOL IN THE BARN** – No alcoholic beverages are to be dispensed or consumed in the alleys of the barn area, there will be a designated area provided for such practices.
38. **BARN SUPERINTENDENT** – The Barn Superintendent has complete authority of the stalling of livestock in the barns, allocation of tie-out spaces and control trimming chutes and trimming in the barns. The duties of the Barn Superintendent are to enforce all barn rules, including cleanliness of barns and aisles and to assist the exhibitors with problems in the barns.
