## **ADMISSION**

The Lloydminster Agricultural Exhibition is pleased to offer a special rate to our exhibitors:

## **OFFICIAL RULES**

- 1) The show is open to all, but the Committee in Charge reserves the right to refuse any entry.
- 2) The Committee in Charge reserves the right to decide any point not covered by the Rules and to correct any error or make any necessary alterations in the Rules and Prize List and act on any disputes and their decision will be final.
- 3) All horses being exhibited must be halter broken and must be securely tied or in the charge of a competent person. No animal shall be allowed to remain loose on the grounds. No animal shall be allowed on the Exhibition Grounds that is not entered in the show.
- 4) All horses must be always under complete control. Colts must be haltered when away from mare or out of stall. No colts allowed running loose.
- 5) All stallions over two years of age must be in a box stall.
- 6) Any horse deemed unmanageable will be excused from the ring.
- 7) Inhumane treatment of a horse, including polling, rapping or other abuse will not be tolerated!!
- 8) All animals on the grounds will be subject to veterinary inspection, if necessary. The cost of the inspection will be the sole responsibility of the owner/exhibitor. No animal having a contagious disease shall be allowed to occupy any stall or building on, or admitted to, the Exhibition grounds, and if any animal has been admitted through an oversight, suffering from any such disease, the Manager shall immediately order its removal from the grounds.
- 9) No person will be allowed to act as judge, who is in any way interested in the exhibits that person is to judge. No person other than officials, stewards and attendants on duty, and the judge of the class may enter the show ring without the permission of the management.
- 10) The exhibitors and grooms are to appear in the ring neat, clean, and suitably attired.

- 11) In the absence of competition in any section, or if the livestock exhibited are of inferior quality, the judges will award only such premiums as they think the animals deserve. They will use their own discretion as to whether they will award first, second or any prize.
- 12) Exhibitors will not move from their assigned stalls without the permission of the stabling superintendent.
- 13) Shavings are provided for initial bedding only.**
- 14) Bag shavings will be available for purchase while quantities last. Square bales of straw may be used in the barn. We cannot accommodate round bales of straw in the barn area.**
- 15) It is required that all stalls are cleaned, and all refuse be placed in the designated areas by 8:00 a.m. each day. NO garbage in manure bins, please.
- 16) All horses must be named on the entry form in all classes, including Hitch and Halter.
  - a) All entries must be made on printed forms, which can be obtained on application to the Show Secretary. These forms should be completed and signed by the exhibitor. Entries must be made in the order mentioned in the Prize List and NO ENTRY WILL BE ACCEPTED UNLESS FEE IN FULL ACCOMPANIES IT.
  - b) Horse Show entries will be accepted only to the limit of the stabling facilities. Stalls are allotted on first come, first serve basis. Submit entries early and avoid disappointment.
  - c) Exhibitors cancelling their entries after the official closing date shall forfeit their entry fees, except on certificate of disability from a qualified veterinarian. No refunds shall be made on cancellations received after the holding of the first class in which the horse is entered. No refund on entry fees will be made on horses incorrectly entered by the exhibitor.
- 17) Where there is only one entry in each of several classes, the Committee reserves the right to consolidate such classes, but the classes so consolidated shall not contain more than five entries each.
- 18) All grooms (juniors & seniors) driving classes may have an assistant if necessary.
- 19) The LAEA ruling on minors showing livestock restricts the age of a minor (determined by the actual age of the minor on the show/event date) showing a bovine or equine, unassisted during a Lloyd Ex show/event to a minimum 9 years of age; and that minors between the ages of 7-8 years are permitted to show a bovine or equine but must be chaperoned by an assistant 15 years of age or older; and that minors 6 years of age and younger are ineligible to show.
- 20) Any exhibitor who makes a false entry or shall attempt to interfere with or influence the judges while in the discharge of their duties, or who shall use contemptuous or abusive language to a Judge in consequence of awards made, is liable to forfeit his right to all prizes they might otherwise be entitled to and may be excluded from exhibiting at this Exhibition. Judges are particularly requested to immediately report any infraction of this rule.
- 21) Original registration certificates need not accompany entries, but a copy of the registration paper must be available if called for at any time during the show.
- 22) Horses that are eligible for registered classes cannot compete in non-registered or grade classes. This includes registered geldings.
- 23) All animals must be owned by and registered in the name of the exhibitor, except in Progeny of Dam, Get of Sire classes and in multiple Hitch Classes.

- 24) **LIABILITY:** Notwithstanding anything to the contrary herein contained, it is understood that each entrant by the act of entry or exhibiting or consigning waives all claims against the Lloydminster Agricultural Exhibition Association Ltd., and/or any of the members, officers or agents thereof for any personal injury, animal injury or death, loss or damage which he, his employees, helpers and/or property may sustain in any way arising out of the operations or activities of the said Company, by any of his helpers or employees or their executors, administrators or assigns, and that any helpers or assistant introduced to or engaged by the entrant through the said Company or through its members, officers or agent shall be at the sole risk and responsibility of such entrant.
- 25) Exhibitors or consignors of animals are liable to occasional accidents, injury or damage to persons coming into contact with them, and therefore shall guard their exhibits and protect the public from coming in contact herewith, and every such exhibitor shall indemnify the Lloydminster Agricultural Exhibition Association Ltd. (LAEA) from and against all claims and demands, costs, charges and expenses which it may incur, suffer or be put to, by reason of an accident or of any such exhibit not being properly guarded or the public not being protected therefrom. The Directors and Committee Members, who will be taking every precaution, cannot hold themselves responsible for any damage to or loss of exhibits.
- 26) All protests shall be made in writing and accompanied by a deposit of \$100.00, which deposit shall be forfeited if protest is not sustained. Said protest shall state plainly, the cause of the complaint or appeal and shall be filed with the Secretary the same day as the decision complained of is made and not later than 3:00 p.m. if made on the last day. Such protests shall be dealt with by the Committee in Charge of the department in which the protest is made as soon as they may deem best; and the decision shall be final. In event of the Committee being unable to come to a decision, the Board of Directors shall deal with the protest.
- 27) Upon any act of discourtesy or disobedience to the Show Secretary, Show Committee members, office staff, grounds staff, stabling superintendent, judges, steward, or any other show official on the part of owner, groom, driver or rider, the entry may be disqualified, and the owner shall forfeit his entry fees and any prize money that he may be otherwise due. The management reserves to itself the power to remove any exhibitor, groom, or animal from the show without being liable for compensation.
- 28) All exhibitors are responsible for their own liability insurance; a copy must be available upon request.
- 29) All hitches are to be hitched in the hitching area located outside of the barn. **NO hitching inside the barn.**
- 30) Release time will be after the last class of the show.



# **Championship Series Draft Horse Show**

1. Each exhibitor entry number will achieve points based on their placing in the class.
2. Each entry will achieve one point for the place they are in as well as one point for each entry that is placed behind the said exhibitor. (Example: 3<sup>rd</sup> place in a class of 7 will be awarded 5 points) (animals shown, not entered)
3. Each Exhibitor will be given two "go arounds" to win points (two classes)
4. Multiple entries by one exhibitor will be given different Entry Numbers and the Entry numbers will be awarded points for the Championship.
5. The horses in each class can vary day to day depending on the choice of the exhibitor, as the Entry number will be where points are awarded.
6. Tallies will be kept at the announcer booth and the championship award will be awarded after the final show on Friday.

## **Championship Cart**

- We have held the traditional Men's Cart and Ladies' Cart in place as these continue to be popular classes amongst exhibitors
- Daily placings will be awarded for each class
- Exhibitor entry numbers will be awarded points
- Championship will be determined by total points from both classes

## **Open Team**

- All teams will compete in one class
- Daily placings will remain as is in each class
- Mares, Geldings, Mixed Teams

## **Champion Gelding Team**

- There will be one champion Gelding Team
- This will be based on total points for both nights in the open classes
- This will be qualified by having two geldings in the entry

## **Champion Mare Team**

- There will be one champion Mare Team
- This will be based on total points for both nights in the open classes
- This will be qualified by having two mares in the entry

## **Champion Open Four**

- Daily placings and payouts available
- Any mix of breeds or sex can compete in the Open Four Event
- All will qualify for points by Entry Number for the Championship Points

## **Champion Open Six**

- Daily placings and payouts available
- Any mix of breeds or sex can compete in the Open Six Event
- All will qualify for points by Entry Number for the Championship Points

## **Ladies' Team and Unicorn**

- At this time these classes will remain as a daily competition and will not qualify for the championship class

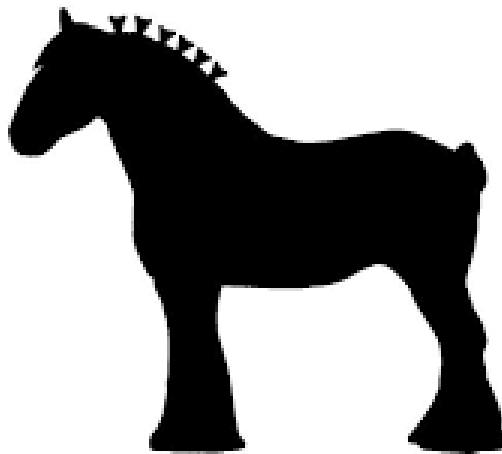

1. All campers must abide by all rules and regulations. If a campsite rules and regulations are adhered to in its entirety, we reserve the right to evict campers without refund including deposit.
2. The campground is a private site and is intended for use by all who wish to camp here.
  - a) We have other major functions that UTILIZE our camp site. Be aware that there may/will be increased activity and noise levels on the grounds and the campground through that period.

  - a. 30-Amp-20 Sites with water, no sewer, Sites #21-40
  - b. 30-Amp -6 Sites POWER ONLY, no water or sewer, Sites #17-20, 41, 42
  - c. 15-Amp -16 Sites-Sites #1-16, POWER ONLY, no water or sewer
  - d. Non-Powered – 37 Sites, Sites #43-79 NO SERVICES

  - b) Camping Sites will be allocated on a first-come, first-served basis. Roping off additional stalls is prohibited
  - ☐ c) Camping passes with your site number will be issued when payment is received. You will need to display this camping pass on your unit.
  - d) All camping is at your own risk and in no way is the Lloydminster Agricultural Exhibition Association Ltd. (LAEA) or any of its parties responsible for loss or damage to camping units while on the grounds.
  - e) Electrical sites will be charged the camping fee, regardless of whether the unit is plugged in or not.
  - f) Anyone NOT requiring power are to camp in the designated non-powered sites-sites 62 and 78-82 areas.
  - ☐ g) It is agreed and understood that if you overuse your power and your breaker trips, we will only reset this breaker during normal operating hours 8:00 am to 5:00 pm daily, so use caution when using equipment inside your trailer.
  - ☐ h) It is agreed and understood if you are camping in a 15 Amp site that these sites are intended to run minimal electrical devices in your camper and is primarily intended for lights, it will not run a heater and lights and a toaster at the same time, and 15 Amp power will not run AC; we will not be responsible for overuse period. I agree to this point \_\_\_\_\_.
  - i) We require campers to provide us with a cell phone and an alternate contact number and the license plate number of the (1) one Vehicle that is allowed in the camping area.
  - j) Each campsite is intended for one (1) camper unit and one (1) passenger vehicle, (including tents within campsite boundary). Camping units must be in the marked campsite boundaries, **no boxing of campers will be allowed.** Only lightweight passenger vehicles and camping units will be allowed in the camping area. Any other vehicles must be parked in the designated area. If there is more than one vehicle in your campsite the extra vehicles will be subject to towing at the cost of the owners of the vehicles.
  - k) Water service will be accessible as long as possible it could be shut off as early as October 1, 2020 depending on weather and freeze up, in this instance there will be no reduction in rates nor refunds as we have no control over the weather.
  - l) Generators will be allowed to be used with respect to your neighbour (**MUST BE A QUIET TYPE GENERATOR**). The generator can be run between **7:00 am and 10:00 pm**.
4. a) If a phone reservation is made, the camper must come to our office to sign the proper documents during our regular office hours. Our office is open Monday to Friday 8:00-12:00 am and 1:00-5:00 pm. Camper may also email this signed document to [reception@lloydex.com](mailto:reception@lloydex.com)
  - b) All Camping fees and extensions are also to be paid within these hours as well.
  - ☐ c) If you have not paid your fees on your deadline date, we will disconnect your power and water and tow your unit from your designated camp site at the camper's cost
5. A maximum of 2-30lb propane bottles per camper unit are allowed. Any bottles larger than 30lbs are prohibited.
6. Camping units and vehicles must not park in fire lanes. Fire lanes must remain clear at all times. Camping units must not form circles or close in camping areas due to fire regulations. If fire lanes are blocked, we reserve the right to have any vehicle towed at the owner's expense.



7. Due to pedestrian traffic in the campground, we ask that all vehicles in the campground be operated in a responsible manner and that vehicle traffic be kept to a minimum. Speed limit is 15 km/hr. This is not posted but needs to be adhered to.
8. **a) No loud music/loud partying, absolutely no disruptive, rude, or rowdy behavior. Quiet time starts at 10:00 pm.**  
☐ b) If Rule number 8 a) is not adhered to and we receive one complaint you will be evicted immediately. No second chances. If you do not leave, we will have your camper towed from our site at the camper's expense. In this instance there will be no refunds, with no actions or further recourse against LAEA, Offices, Directors or Staff  
☐ c) If any camper or guest acts rudely and/or is abusive to any of our staff for any reason whatsoever, they will be evicted immediately. If you do not leave as directed your camper will be towed at the camper's expense. No second chances with no further recourse or action against LAEA Offices, Directors or Staff.
9. No campfires or fireworks are permitted. Propane barbecues and propane fire pits are allowed.
10. Absolutely No pets allowed, without prior approval from LAEA.
11. Non-approved vendors are prohibited in the campsite area.
12. ATVs, golf carts, horses and dirt bikes are prohibited.
13. Absolutely No alcohol outside of the campsite is allowed.
14. No additional structures of any kind, other than awnings, are allowed.
15. No household furniture allowed in campsites (campsites are intended for one (1) camper unit and one (1) passenger vehicle only). Picnic tables are acceptable.
16. Garbage tanks will be located in the camping area and campers are required and responsible for disposing of garbage into the tanks.
17. Gray/black water and sewer disposal is the responsibility of the camper. Scheduled on-site disposal is available by contacting Westbay Vac Services at (306) 825-3750. You can discuss fees with that company.
18. If camper vacates spot, but intends to return, please notify the office so we do not rent the spot out to anyone else; you must be fully paid to maintain your site.
19. Campsite must be vacated no later than 11:00 AM on the date following last paid night of camping. Camping area should be left in the same condition that it was upon arrival.
20. The campsite is located close to one of our work areas and arenas. We cannot be held responsible for noise from equipment or our work crew, or people who utilize our grounds.

The LAEA or any person that is acting on behalf of the LAEA (i.e., security, volunteers, employees, etc.) retains the right to remove any person(s) that is not acting in accordance with the above-listed rules. Failure to vacate the campsite in the same condition that it was in upon arrival will result in a fine to cover the cost of the cleanup. The LAEA and its Board of Directors, Staff and Volunteers and all their associated parties and all the agents acting on behalf of the LAEA assumes no responsibility for fire, theft, accidents, injuries or loss from any cause.
